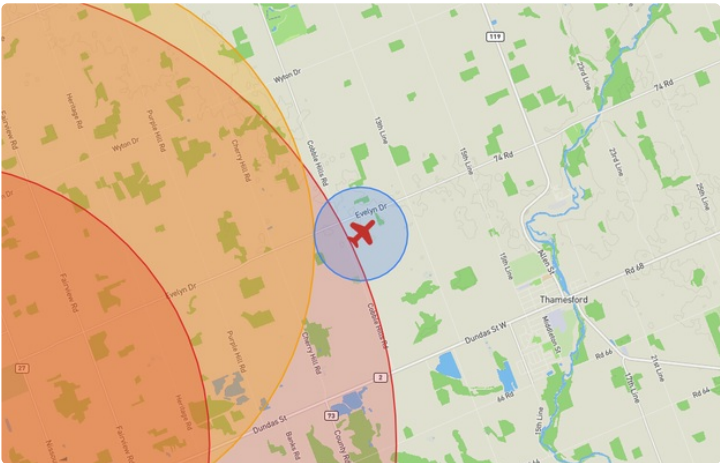

FLIGHT AREA MAP



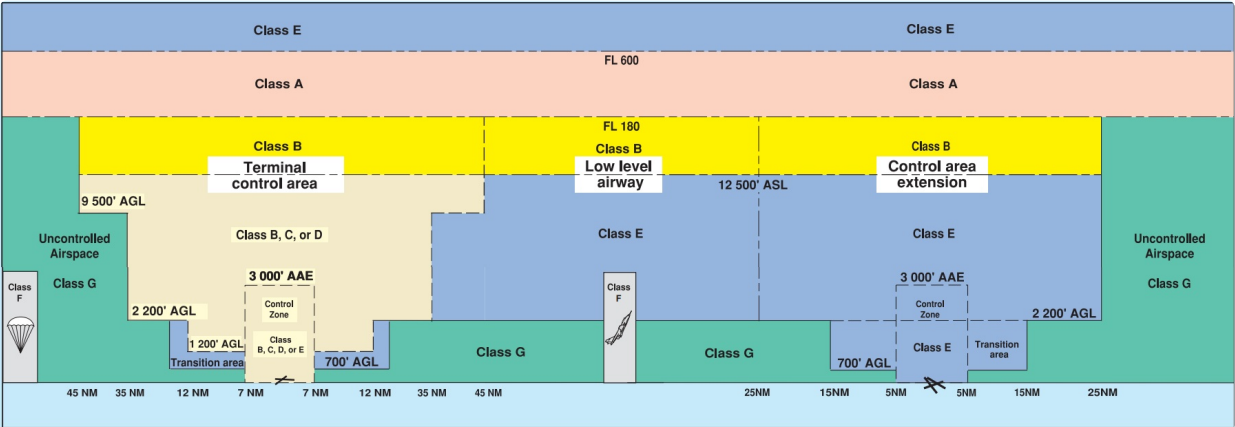

LONDON VFR TERMINAL PROCEDURES CHART



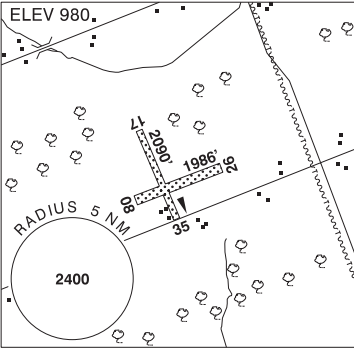

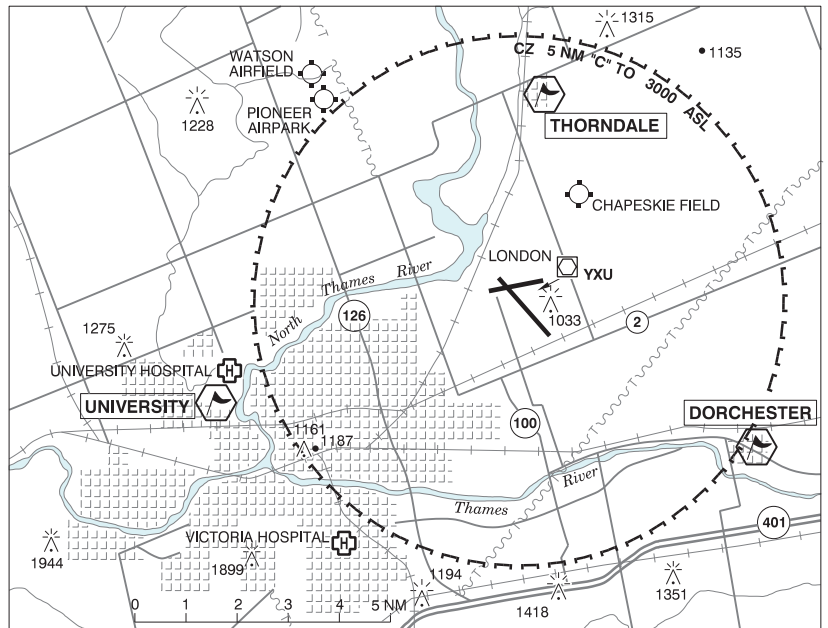

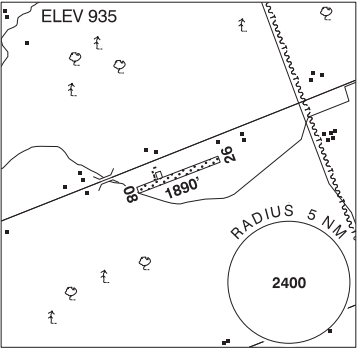
