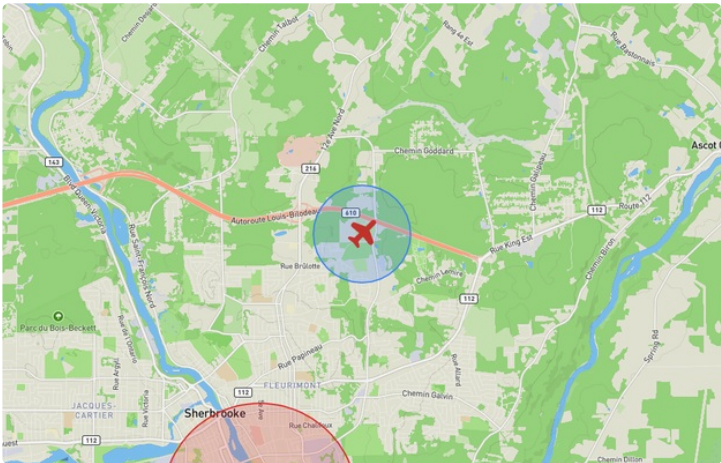

FLIGHT AREA MAP



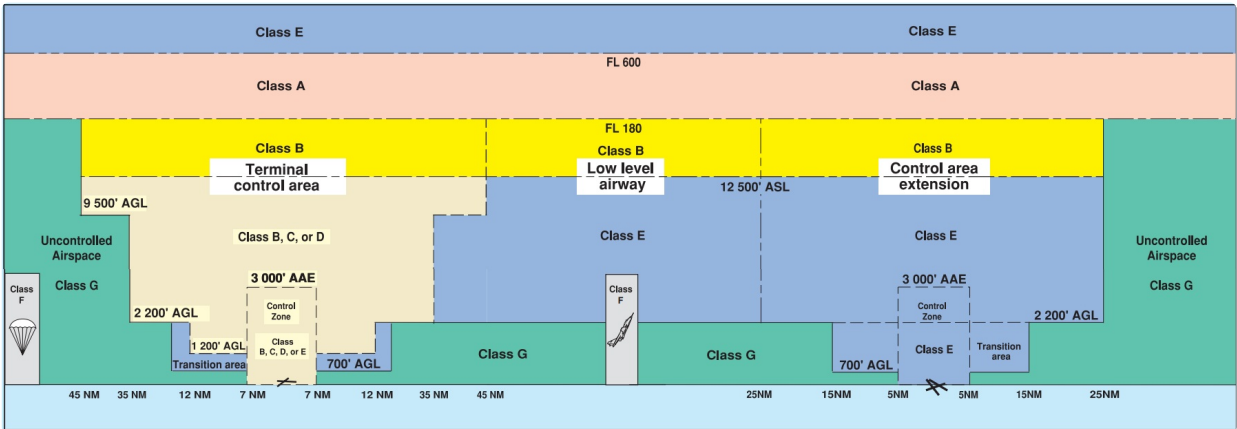
